## Iran ranks among the two largest sales markets for Medical technology in the Middle East

### Strong demand for quality Medical technology

- Iranian imports of Medical technology have grown by 25% annually over the past five years.
- The Iranian agricultural technology market ranks second in the Middle East after Saudi Arabia.
- The healthcare and medical sector's market value in Iran worth almost \$96 billion in 2017 and is predicted to rise to \$110 billion in 2025.

## Iran's Pharmaceutical Market Map

Within this part, we are going to look at the Iranian pharmaceutical market from the valid national organizations. The IFDA valued the Iranian pharmaceuticals market 3.7 billion USD from March - November 2018 including domestic, import and licensed products. Moreover, according to the president of the CBI the importation value of pharmaceutical and medical necessities is around 4 billion in the same period in 2019. As depicted in the charts below, the Iranian pharmaceutical sectors experienced a steady growing market in the last 3 years.

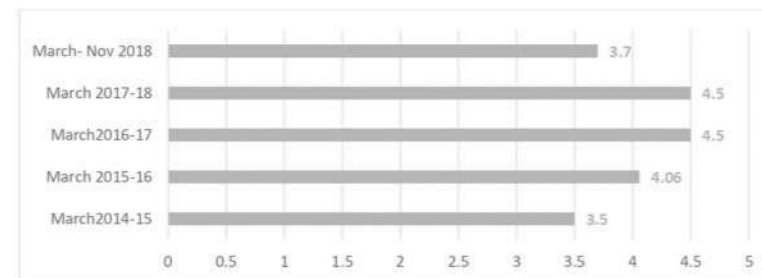

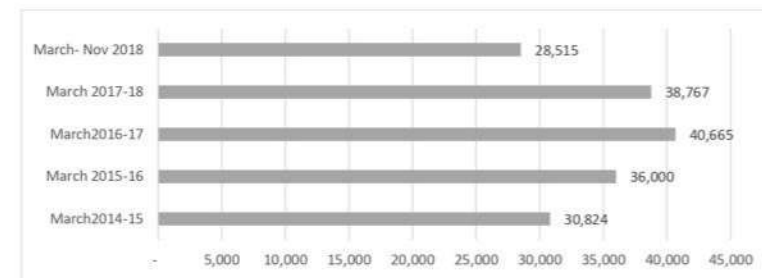


Graph 1. Pharmaceutical Products Market Size -Sales in billion USD

## Key Market Players of the Iranian Pharmaceutical Products

Iranian Food and Drug administration (IFDA), which is a sub-branch of MOHME, is responsible for the management and regulation of the Iranian pharmaceutical sector, including biological and herbal products. The national regulatory system of Iran is composed of two main sectors; pharmaceutical affairs and the national control laboratory. The former is responsible for supervision of manufacturing, distribution, and importation of medicines. The latter checks the quality, origin, etc. of the medicines.

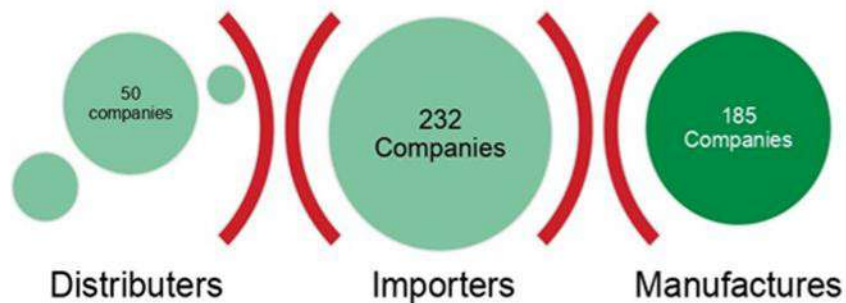
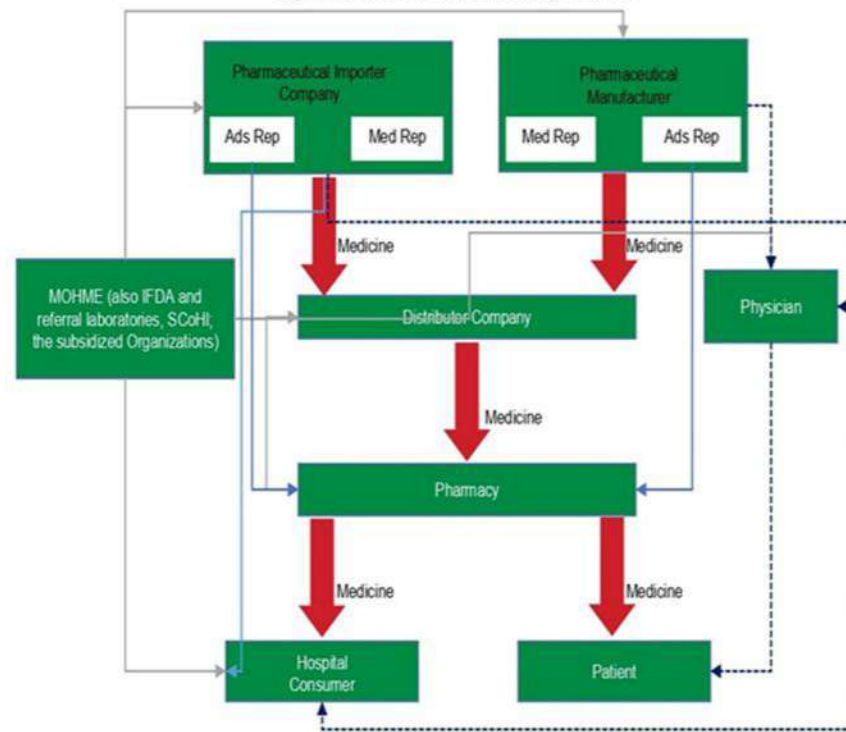


Figure 2. Pharmaceutical Market Players in Iran







## Iran exporting medical equipment to 63 world countries

- Last year, some 1,060 trillion rials (about \$2.1 billion) worth of medicine and medical equipment were manufactured inside the country.
- Around 99% of the medicine supplied to the domestic market is produced by Iranian companies.
- Iran plans to increase the exports of medicine to around \$200 million in the current year from some \$60 million last year,
- A total of 227 knowledge-based firms are supplying medical equipment for health centers across the country, according to the Vice Presidency for Science and Technology.

## Facts on the Iranian medical industry

1. **Pharmaceutical Industry:** Iran has a well-established pharmaceutical industry, with a large number of domestic pharmaceutical companies producing a wide range of medications. The country also exports pharmaceutical products to various countries.
2. **Medical Device Manufacturing:** Iran has a growing medical device manufacturing sector, producing a variety of medical equipment and devices to meet domestic demand and for export.
3. **Research and Development:** The country has been investing in research and development in the medical field, leading to advancements in medical technology, drug discovery, and healthcare innovation.
4. **Healthcare Infrastructure:** Iran has a network of modern hospitals, clinics, and healthcare centers, particularly in urban areas, providing a wide range of medical services.
5. **Medical Tourism:** Iran has emerged as a popular destination for medical tourism, attracting patients from neighboring countries and beyond for medical treatments, including cosmetic surgery, organ transplants, and advanced medical procedures.

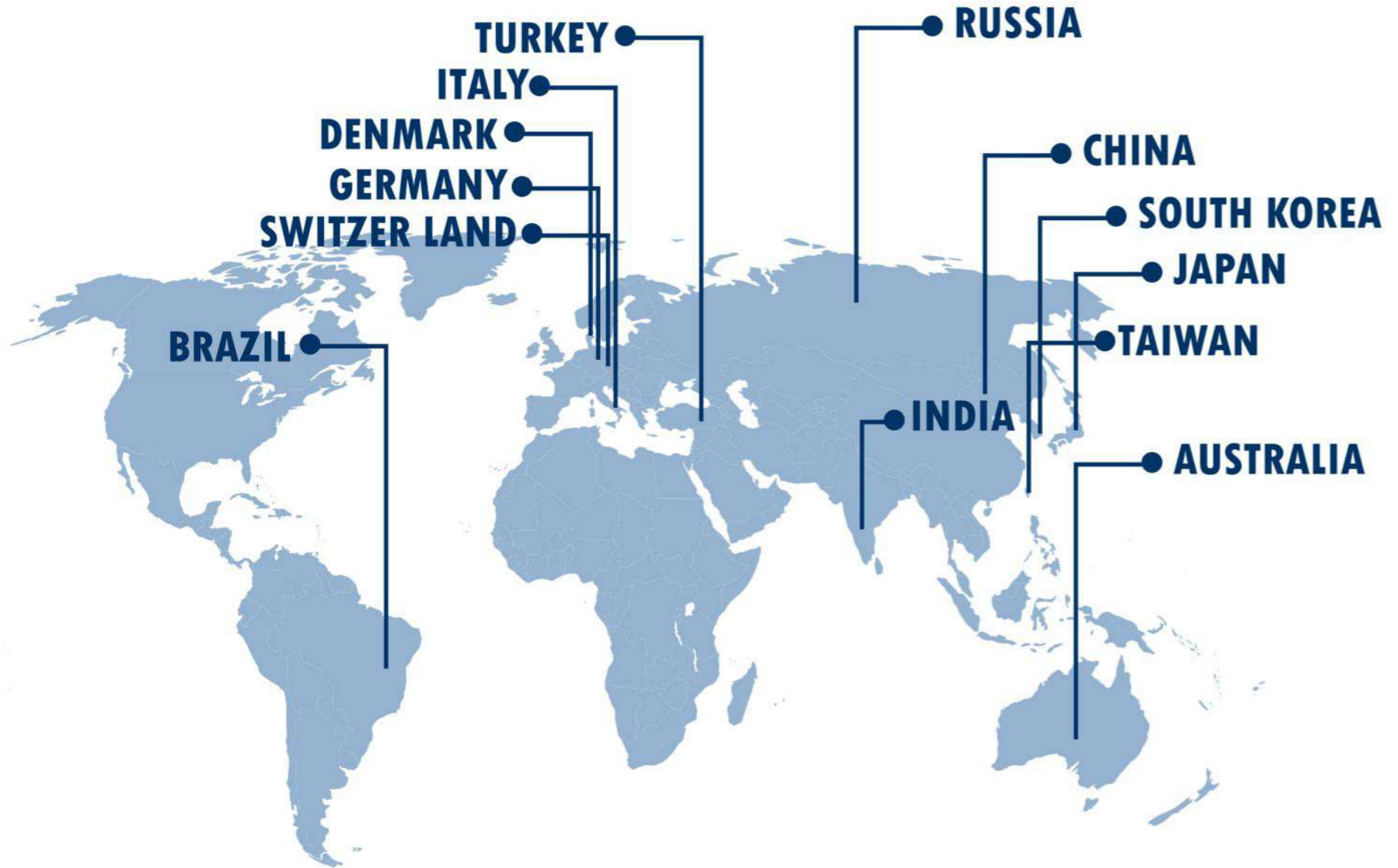
